The WHY

PEDRI has set significant objectives within the domain of data intensive research. Our goals encompass ensuring sector wide best practices in public engagement and involvement in data intensive research, establishing a supportive community program, creating a central resource hub, and conducting national awareness campaigns to educate the public. These initiatives align with DARE UK's mission, which centres on building trust between the public and the data research community. Through these pursuits, PEDRI will make a valuable contribution to the sensitive data research community and the wider data intensive research community by enhancing transparency, expanding inclusivity, and promoting adoption of best practices. This, in turn, cultivates a stronger sense of trust and confidence in the field of data intensive research, a key challenge in this domain. Another challenge in this field is providing support for patient and public involvement professionals. A support network and resource hub will serve as a point of assistance for professionals to collaborate, find solutions to challenges, and avoid duplicating efforts or reinventing the wheel.

PEDRI's core objectives align with several of DARE's recommendations, notably the aspect of 'demonstrating trustworthiness.' PEDRI is committed to being a driving force in fulfilling these objectives and contributing to building trust with the public. While Public Involvement and Engagement (PIE) has been explored to some extent, to our knowledge, there is currently no predominant group dedicated to PIE specifically in the realm of data-related matters. PEDRI's core objectives have acted as a compelling incentive for individuals and organisations to join our initiative. The fundamental need for a community focused on identifying solutions for PIE in the context of data research serves as the driving impetus behind PEDRI's mission. As PEDRI encompasses health and non-health data, We believe that PEDRI will not duplicate work of existing groups such as useMYdata or Understanding Patient Data, instead it will encourage cross-organisational coordination and communication using our existing connections within the Alliance and other partners. The Alliance will serve PEDRI as a vehicle to reach out to existing groups, with the aim is to drive alignment, encourage sharing of resources and signposting to best practice. The PEDRI sub-group will facilitate this by bringing together health data organisations.

- Development and Adoption of PEDRI Standards: PEDRI seeks to finalise Best Practice Standards (BPS) for
 Public Involvement and Engagement in Data Research and Statistics. The outcome of this effort could lead
 to potential Working Group topics related to the implementation and adherence to these standards, as
 well as monitoring their impact on data research practices.
- Community Engagement and Knowledge Sharing: PEDRI plans to establish a community program and
 promote knowledge sharing within the sector. This could give rise to WG or sub-group discussions on
 community engagement strategies, effective knowledge-sharing practices, and methods to enhance
 inclusivity and transparency in data research.
- 3. Central Resource Hub and Website Enhancement: PEDRI intends to create a central resource hub and improve the functionality of its website. Subsequently, WGs may support the Website re-design and explore topics related to the maintenance and expansion of this resource hub, ensuring it remains up-to-date and useful for researchers and professionals.
- 4. National Public Awareness Campaigns: The IG aims to plan national awareness campaigns. A WG would work on developing a plan which considers public awareness strategies and effective communication methods for campaigns on public perceptions of data research. The WG will also actively link into and work with other actors involved in Campaigns (e.g., Department of Health and Social Care, NHS England, and the Sub-national Secure Data Environments)

These initial ideas for outputs and potential WG topics demonstrate how PEDRI's efforts could lead to the development of specific initiatives and discussions that contribute to the sensitive data research community and the broader data intensive research ecosystem.

The HOW
